This is a 12-month agreement. Clients must agree to abide by all Therapeutic Kneads' policies and understand that the Wellness Plan is valid only for the plan holder on the account. Unused monthly massages roll over as long as your agreement remains current. The only shared portion of the Wellness Plan are the prepaid massages. The other plan benefits are available for your use only and cannot be applied to any other person regardless of the payee. Therapeutic Kneads reserves the right to change Wellness Plan discounts at any time. **Plan benefits cannot be combined with any other promotion or discount.** At the end of the 12-month term, all plan benefits must be used and may not be extended.

In the event of extenuating circumstances, a cancellation request form must be completed and submitted for consideration. A 90-day notice is required. Management reserves the right to approve on a case-by-case basis.

**Monthly Credit/Debit Card Payment Information**

Your Wellness Plan must be automatically billed each month from a valid credit/debit card. **Fees are billed on the original sign-up date and can be forced-charged up to 5 days prior to the billing date and will then resume on the normal charge date.** All payments to Therapeutic Kneads are non-refundable. The Wellness Plan is between Therapeutic Kneads and the above member only. The current 30-day period begins on the sign-up date. Billing will continue on a month-to-month basis for a period of 11 more months, at which time you will have the option to renew under the current terms and have the renewal fee waived. If you decide to renew at a later date, a renewal fee will be required. Gift cards **cannot** be applied to your monthly plan fee. Gift cards can however, be used towards any additional treatments or retail purchases.
